Payment rules for educational services

at Non-public Educational Institution 'Wroclaw International School' (WIS)

1. Type of payment:

- a. **Tuition fee**: it is a fee for the whole duration of the education services as defined in the Education Agreement. The payment date is defined in the Education Agreement.
- b. **Application fee**: it is a one-off fee paid during the admission process of a child and for children returning to the School after the break longer than one year. The fee covers the procedures related to the admission process, tests and interview. Except for the situation when a child is not admitted for lack of places, this fee is not refundable.

2. Annual Tuition Fee Breakdown into Installments

WIS offers the option of the tuition fee breakdown into installments only to those Parents/Legal Guardians whose education-related fees are not refunded or paid directly by the employer. Payments in installments are not offered in case the education is refunded by the employers of the Parents/Legal Guardians.

A written request to break down the payment into installments should be submitted to the Admission Officer at the office of the Foundation not later than before the first day of education at WIS.

3. Payment Terms

- a. Tuition and remaining fees are paid in Polish Zloty (PLN) to individual bank account number indicated in the Educational Agreement. All payments should be transferred to an **individual bank account number** which will be assigned **to each child separately**.
- b. The deadline for the tuition fee and other fees payment is indicated in the Education Agreement. The effective date of payment shall be the date when it has been credited at the Foundation's bank account.
- c. Any delay in tuition fees or remaining fees payment shall result in the accrual of default interest in the amount equal to the statutory default interest starting from the day following the deadline.
- d. A child may be not allowed to participate in classes or the Education Agreement may be terminated in case of failure to pay the tuition, the installments or remaining fees.
- e. The child's Parent/Legal Guardian is always responsible for all payments of the tuition irrespective of the arrangements between the Parent/Legal Guardian and their employer.
- f. Please note that no educational report or certificate shall be given to a child whose financial liabilities have not been settled.
- g. The bank fees for transfers made from abroad as well as all other fees charged by banks for the given transaction may not be deducted from the fees payable under the Education Agreement.
- h. All payments made by a Parent/Legal Guardian, irrespective of the transfer title, shall be first recognized as settlement of past due payments, e.g. past due tuition, default interest.

In the case of refunds of overpaid tuition fee, the tuition fee value to be reimbursed is calculated in proportion to the 10 months of WIS academic year - which begins: 1.09.2019 and ends: 30.06.2020.

If child starts his/her education at WIS after Spetember 1st, 2019, the tution fee is recalculated proportionally, ie 1/10 of the annual tuition fee per one month of attendance.

If the due date of payment of the installment falls on a statutory day off from work, the payment deadline shall be postponed to the next working day following the day off.
